## Installing The Rails And System In A Rack

Assemble the rails and install the system in the rack following the safety instructions and the rack installation instructions provided with your system.




Figure 1. Installing the Rails and System in a Rack

## **Using The System Without A Rack**

You can use the system without the server rack. When you are using the system without a rack, ensure that you follow these guidelines:

- The system must be placed on a solid, stable surface that supports the entire system.
  - NOTE: The system must not be placed vertically.
- Do not place the system on the floor.
- Do not place anything on top of the system. The top panel may deflect under the weight and cause damage to the system.
- Ensure adequate space around the system for proper ventilation.
- Ensure that the system is installed under the recommended temperature conditions as stated in the Technical Specification Environmental Section of this document.

CAUTION: Failure to follow these guidelines may result in damage to the system or physical injury.




Figure 2. Using the System Without a Rack

# Connecting The Keyboard, Mouse, And Monitor (Optional)




Figure 3. Connecting Keyboard, Mouse, and Monitor (Optional)

Connect the keyboard, mouse, and monitor (optional).

The connectors on the back of your system have icons indicating the type of cable to be plugged into each connector. Be sure to tighten the screws (if any) on the monitor's cable connector.

# **Connecting The Power Cable**




Figure 4. Connecting the Power Cable

Connect the system's power cable to the system and, if a monitor is used, connect the monitor's power cable to the monitor.

# **Securing The Power Cable**




Figure 5. Securing the Power Cable

Bend the system power cable and secure the cable in the retention clip.

Plug the other end of the power cable into a grounded electrical outlet or a separate power source such as an uninterruptible power supply (UPS) or a power distribution unit (PDU).

# **Turning On The System**




Figure 6. Turning on the System

## **Installing The Optional Bezel**




Figure 7. Installing the Optional Bezel
